

Bank Draft Plan

The Bank Draft Plan authorizes the bank to pay the Armfield Civic Center automatically each month from a checking or commercial savings account. Payment of membership and key tag activation fees are required at joining, membership fees will be prorated for new members that join after the 5th day of the month. New Members or Members who change their account information must provide a voided check from their account to set up a bank draft (sorry, deposits slips are not permitted in place of a voided check. Bank Drafts are on a continual monthly plan and are continuous until membership with the Armfield Civic Center is cancelled. Rates for Bank Drafts change automatically when rates increase or a Member's age places them in a new membership package. Members who receive support under our Scholarship program are required to complete a renewal application annually. Failure to do so will result in an increase in Membership rates to the full monthly or yearly amount. Refunds will not be given for the increased Membership dues or resultant bank fees if the recipient fails to comply with this requirement for any reason. It is the responsibility of the Member to be aware of these rate increases or age categories.

Rejoiner's Fees

A Rejoiner's Fee is required for past members, rejoiner's fee will be waived if past member pays for an annual membership plan. All past members who wish to reactivate their membership account on a monthly basis will be required to pay a rejoiner's fee. Fees will vary according to past membership packages.

Bank Draft Cancellation

A bank draft cancellation form must be completed by the Member and membership cards returned for Bank Drafts to be terminated. This is the responsibility of the Member. Members may fax to 336-368-4115 or mail a letter to the Armfield Civic Center, PO Box 1250, Pilot Mountain, NC 27041 requesting cancellation; however, the Armfield Civic Center cannot assume responsibility for nonreceipt of cancellations that are not performed in person. Members who cancel by fax or letter are strongly encouraged to call Member Services at 336-368-2012 to confirm receipt of faxes or letters. Any cancellations after the 5th day of the month will draft the following month. Please verify accuracy of payments from your account to the Armfield Civic Center on a monthly basis.
