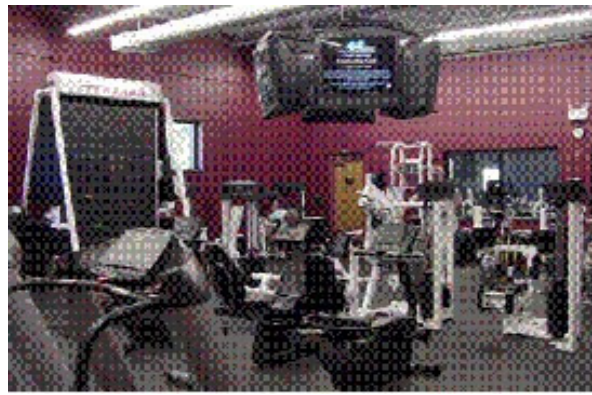

Corporate Wellness Memberships occurs on a month to month continuous basis . Payment is accepted by bank draft only.

Bank Draft (EFT): This is an automatic monthly payment from a checking or savings account. Dues are drafted within the first five working days of each month. If a new member enrolls the 1st thru 5th day of the month they will have to pay membership fees for the entire month. If a new member enrolls after the 5th day of the month, first month's dues will be pro-rated allowing the member to use the facilities immediately. After the initial dues, payment will be drafted from the members account. It is the member's responsibility to inform the Center if the monthly bank draft appeared incorrectly or did not appear on your bank statement. Failure to report and make restitution on your monthly account may result in loss of active status.

Bank Draft Cancellation: A 30 day written notice cancellation must be completed by the Member and membership cards returned for Bank Draft to be terminated. This is the members responsibility.
