The Armfield Civic & Recreation Center welcomes all people who want to become members and program participants. We strive to provide an opportunity for all the residents of Pilot Mountain and surrounding communities to become connected with our quality services, which are offered in a clean and safe environment.

It is the policy of the Armfield Civic & Recreation Center to provide recreational opportunities to everyone. People who are not able to pay the standard membership and programs fees may be awarded scholarships based on their income and their demonstrated ability to pay. Scholarships packages are discounted 25% to 50%. Realizing the need to include all communities, the Armfield Civic & Recreation Center will offer financial assistant to families meeting the guidelines listed in this document. All applicants will be required to pay a portion of the fees for each membership. Scholarships may be limited by resources available at the time the application is processed.

Application Process

Complete the application and provide the following documentation. (Applications submitted without the required documentation cannot be processed.)

Copy of most recent Tax Return (1040, 1040A, 1040EZ) If you do not have a copy of your tax return, you may obtain one by calling the IRS @ **1-800-829-1040**.

One other form of documentation:

Two consecutive pay stubs for each wage earner
Social Security—Annual Award Letter from SSI
Unemployment Payments

Note: If married, documentation must be submitted for both spouses.

Documentation of extenuating circumstances to be considered (example: Medical treatment, education cost, unemployment, etc.)

Return your information to the Front Desk in a sealed folder for confidentiality purposes.

Application will take 2 to 5 business days to process.

Scholarships are reviewed annually for membership and seasonally for programs.

If you do not re-apply, your membership rate may go up to full price. Please report any and all changes to your household income.
